### **ITEM NO 01: 12 AIR CONDITIONS**

#### **1.M/s Shaheer Traders:**

Upon checking the details of the specifications provided by the said vender reflects that the vender (M/s Shaheer Traders) meets the technical requirements for the subject item i.e. (Item No 01). The vender satisfy the essential eligibility criteria and technical requirement for item no 01 of the tender No. D&SC-South Tender/Installation of 12 Air Condition in Family Courts, installation of 04 E-KIOSKS, Supply of 05 Steel Electric water coolers with filtration facility and supply of 30 Water Dispensers for District Courts South, Karachi/2025-2026/4.

#### **2.M/s Al Madina Enterprises:**

Upon checking the details of the specifications provided by the said vender reflects that the vender (M/s Al Madina Enterprises) meets the requirements for the subject item i.e (Item No 01). The vender satisfy the essential eligibility criteria and technical requirement for item no 01 of the tender No. D&SC-South Tender/Installation of 12 Air Condition in Family Courts of District Courts South, Karachi/2025-2026/4.

#### **3.M/s Mushtaque and Sons:**

Upon checking the details of the specifications provided by the vendors is discussed herein above; it appears that the M/s Mustaque offered the make and model of the air condition as Haier HS4248 FCD and claimed that the gas used in the brand and model is R-410 A while upon checking the specifications of the subject brand it was revealed that the subject brand was not using or having the claimed gas i.e R-410-A and while the subject brand has R-32 which is not required. Further, the said vender also claimed that the ante corrosion feature is also in the subject brand, while upon checking the subject brand it was confirmed that the subject brand is not having the ante corrosion feature. Therefore, M/s Mustaque and sons failed to meet the technical requirement for item no;01, hence is disqualified.

#### **Conclusion:**

The Vender/Bidder M/s Mushtaque and sons does not satisfy the essential eligibility and technical requirements for the subject tender for the reasons mentioned above. Whereas, the venders (i) M/s Shaheer Traders and (ii) M/s Al Madina Enterprises satisfy the essential and technical requirements for item No. 1 of tender No. D&SC-South Tender/Installation of 12 Air Condition in Family Courts of District Courts South, Karachi/2025-2026/4.

liters instead of 100 liter. Therefore, M/s Mustaque and sons failed to meet the technical requirement for item no;03, hence is disqualified.

#### **Conclusion:**

The Vender/Bidder M/s Mushtaque and sons does not satisfy the essential eligibility and technical requirements for the item No. 3 of subject tender for the reasons mentioned above. Whereas, the vendors (i) M/s Shaheer Traders and (ii) M/s Al Madina Enterprises satisfy the essential and technical requirements for tender No. D&SC-South Tender/ Supply of 05 Steel Electric water coolers with filtration facility for District Courts South, Karachi/2025-2026/4.

Upon checking the details of the specifications provided by the vendors is discussed herein above; it appears that the M/s Mustaque offered the water dispenser with refrigerator instead of without refrigerator. Therefore, M/s Mustaque and sons failed to meet the technical requirement for item no;04, hence is disqualified.

**Conclusion:**

The Vender/Bidder M/s Mushtaque and sons does not satisfy the essential eligibility and technical requirements for the item No. 4 of subject tender for the reasons mentioned above. Whereas, the venders (i) M/s Shaheer Traders and (ii) M/s Al Madina Enterprises satisfy the essential and technical requirements for tender No. D&SC-South Tender/ supply of 30 Water Dispensers for District Courts South, Karachi/2025-2026/4.
