**Technical Evaluation Report**

**Subject:** Technical Evaluation Report of Tender No. D&SC-South Tender/ Establishment of E-Library (Unit I), (Unit II) and (Unit III) for Karachi Bar Association (KBA)/9

**Reference:** Tender Reference No. D&SC-South Tender/ Establishment of E-Library (Unit I), (Unit II) and (Unit III) for Karachi Bar Association (KBA)/9

In accordance with Rule 41 of the SPPRA Rules 2010 (Amended), the Procurement Committee convened on May 4, 2026, at 11:30 a.m. at the District & Sessions Court, Karachi South, to conduct the electronic opening of bids via EPADS. However, a technical discrepancy was identified wherein the system's opening time was inadvertently set to 11:30 p.m. instead of the scheduled 11:30 a.m. To uphold transparency and procedural integrity, and noting that the system time contradicted the official Tender Notice, the Committee resolved to reschedule the formal opening to May 5, 2026, at 11:30 a.m. Furthermore, since the publicized submission deadline has passed, the Committee affirmed that no further bids will be entertained to ensure equitable treatment; all currently submitted bids shall remain secured and unopened within the EPADS portal until the rescheduled session.

Accordingly, the meeting of the Procurement Committee was duly convened today upon the attendance of the members as well as the participating bidder(s).

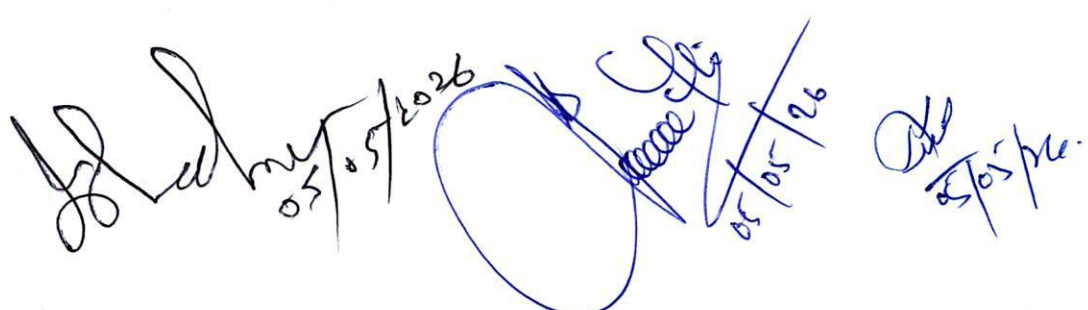
Evaluation Overview

In accordance with Rule 46(2) of the Sindh Public Procurement Rules (SPPRA), 2010 (Amended), the Procurement and Purchase Committee conducted a rigorous technical scrutiny of the proposals submitted for the subject tender. The evaluation focused on mandatory eligibility criteria, technical specifications, and compliance with the bidding documents.

Bidder Status and Technical Compliance

Following a detailed analysis of the documentation provided, the Committee’s findings are as follows:

- Bidder Name:** M/s SIMCO INTERNATIONAL
- Technical Standing:** The bidder’s technical proposal was found to be fully compliant with the prescribed specifications and essential eligibility requirements. The equipment/services offered align with the technical benchmarks established for the E-Library project (Units I, II, and III).
- Determination:** Substantially Responsive and Technically Qualified.



## • Committee Observations and Recommendations

After thorough deliberation and verification of the technical documentation, the Committee observed that **M/s SIMCO INTERNATIONAL**, being the sole participant, has successfully met all mandatory qualification thresholds. Consequently, the Committee records the following resolutions:

- **Responsiveness:** The bidder is declared **Technically Qualified** as per the evaluation criteria outlined in the bidding documents.
- **Advancement:** In compliance with the Single Stage–Two Envelope procedure, the qualified bidder shall proceed to the financial opening stage of the procurement process.
- **Financial Opening:** The Financial Proposal of the technically qualified bidder shall be opened on a date and time to be officially communicated to the bidder and stakeholders.
- **Integrity of Bids:** Until the formal opening, the Financial Proposal shall remain unopened within the **Electronic Procurement and Accrued Disbursement System (EPADS)** to ensure transparency and procedural sanctity.
